



Grant of Stock Options and Restricted Stock Units

San Diego, California and Sydney, Australia (Friday, 9 March 2018 AEST) – REVA Medical, Inc. (ASX: RVA) (“REVA” or the “Company”) announces that a total of 426,000 options to purchase common stock (equivalent to 4,260,000 CDIs) were granted to employees and 189,000 Restricted Stock Units (equivalent to 1,890,000 CDIs) were granted to employees and a consultant of the Company, under the Company’s Amended and Restated 2010 Equity Incentive Plan. Details of the grants are provided in the attached Appendix 3B.

Following the grants, there are outstanding options to purchase a total of 6,546,491 shares of common stock (equivalent to 65,464,910 CDIs) and a total of 691,500 RSUs (equivalent to 6,915,000 CDIs) outstanding and subject to vesting under the Company’s equity incentive plans.

REVA Medical is a medical device company focused on the development and commercialization of bioresorbable polymer technologies for vascular applications. The Company’s lead products are the Fantom and Fantom Encore bioresorbable vascular scaffolds for the treatment of coronary artery disease. REVA is located in San Diego, California, USA and employs over 50 people in the U.S. and Europe.
